Veterans Are Heroes Forever



Greetings from Veterans Are Heroes Forever 501 (C) (3) non-profit organization.

We want to get you caught up on some of our accomplishes and future events for our veterans. First, we formed on

October 31st, 2023, and received our official letter of approval from the Internal Revenue Service Tax Exempt and Government Entities this past April 2024.

Since we formed, we have passed out over 60 turkeys, gave away over \$6,000 worth of Amazon return gift boxes to over 175 veterans and their families and that was just last November and December. This year over \$7,000 worth of gifts, 6 boxes of clothing, 25 blankets, food, beverages, bread and pastries to veterans here at our Wolcott Senior Center, The Summit at Plantsville, serving over 200 veterans and family.

On June 1st we had our 1st Patriotic Pillows for Veterans event at the DePaolo Middle School where we presented over 50 Patriotic Pillows to our Veterans in person and to others who could not attend for various reasons. Twenty-Five went to veterans who were residents at The Summit at Plantsville.

We also were able to help a few local veterans with financial assistance, food and clothing too. VAHF will continue assisting whenever we can, thanks to your donations. We plan on receiving more boxes in the future and hope to have a bunch for Christmas like last year.

We have currently finished a very successful campaign raising money for veterans with our 3-month calendar gifts with over 90 opportunities to win. Thanks to everyone who participated. I encourage you to make additional donations at our website, www.vetahf.com.

I have been speaking at local VFW's, Senior Centers, to get our mission statement and focus to the public. I would be happy to speak at your group.

On September 17th we hosted a very successful ceremony with many in attendance. for Constitution Day at our VFW Post 1979 here in Wolcott. We will do this again next year. Speaking about Constitution Day, I will be conducting a 12-part Constitution Lecture and seminar series of classes beginning on October 16th 3pm at 87 Main Street Thomaston. Registration will be required as I am going to limit class size for better participation from students. Each lecture will be 30 to 35 minutes in length with time to discuss the material and a review. I want to thank the Wolcott Chamber of Commerce for awarding me the Erma Costa Community Service Award on September 26th for the work I am doing to assist our Veterans. It was an honor to receive that award. Erma had done so much for our town. My children went to Monarch, and they loved it there.

I want to thank all the volunteers who have been assisting since our inception last year. You all have contributed so much to make this organization a success. Without your passion and commitment to our cause and our veterans none of this would be possible. We need more volunteers, and more young adults would be great.

I am planning other events for later this year so keep following us. I am looking for more volunteers and donations or grants so we can do more for veterans. Thank you so much.


Ecumenical Thanksgiving Service

New Laws for 2024

ach legislative session, there are hundreds of bills introduced in Hartford, some which unfortunately, do not benefit



our communities. But there are several recent bills that were signed into law and now in effect that I wanted to highlight, which may be of interest to you, your family or your business.

And please remember that your voice truly matters when it comes to influencing the legislative process in Hartford. There are many times when new bills are proposed that thankfully are stopped because of pushback from the public.

Earlier this year, we stopped (at least temporarily) policies and legislation put forward by the Democrat majority that would have mandated you drive an electric vehicle. House and Senate Republicans led the charge, and together with your emails, letters and phone calls, the governor halted his pursuit of it.

That's why it is so critical to be involved in the process and reach out to your legislators to let them know your thoughts on bills when they are proposed.

Public Act No. 24-39 - Requires home health care, home health aide, homemaker companion, and hospice agencies to require employees to wear an identification badge with his or her name and photograph during each client appointment.

Public Act No. 24-16 - Allows Police Chiefs, Fire Chiefs, and Emergency Medical Service chiefs and administrative heads to, declare that a police officer, uniformed paid or volunteer firefighter, or EMS personnel died in the line of duty if the death was caused by a cardiac event, stroke, or pulmonary embolism within 24 hours after the individual finished a shift or training.

Public Act No. 24-46 - Exempts property tax for either a primary dwelling or motor vehicle for each veteran who has a permanent and total disability rating.

Public Act No. 24-65 - Requires anyone convicted of intentionally injuring or killing a peace officer's animal or a volunteer canine search and rescue team's dog to pay restitution to the law enforcement unit, entity, or individual that owns the animal. the restitution may include the cost of veterinary services and, if the animal is killed or rendered unable to perform its duties, the costs and expenses of purchasing and training a replacement.

Public Act No. 24-141 - existing law requires managed residential communities (MRC) provide each resident a written residency agreement clearly setting out the resident's and the MRC's rights and responsibilities. This act modifies those agreements and establishes notification and reimbursement requirements for certain resident fees, including (1) how often fees may increase, (2) the schedule or specific dates of these increases, and (3) the history of fee increases over the past three calendar years. The act also requires that agreements entered into on or after October 1, 2024, specify any nonrefundable charges, fees, expenses, and costs.







TOWN OF WOLCOTT REFERENDUM November 5, 2024



Take notice that the proposed amendments to the Wolcott Town Charter, which will be placed on the November 5, 2024, ballots, for the electors of the Town of Wolcott to approve or to not approve, are listed below. **The referendum is to take place on Tuesday, November 5, 2024, between the hours of 6:00 a.m. and 8:00 p.m. at all voting districts.** The ballet question relating to the proposed amendments to the Charter will appear as follows:

"SHALL THE TOWN OF WOLCOTT CHARTER BE AMENDED AS PROVIDED IN THE CHARTER REVISION COMMISSION'S FINAL REPORT DATED MAY 22, 2024, TO BECOME EFFECTIVE JANUARY 1, 2025?

2024 CHARTER REVISIONS FOR PUBLICATION Charter Revision Commission's additions in bold and deletions in brackets. This is for subsections changed only.

SEC. 202. ELECTIVE OFFICERS.

(a) At each municipal election there shall be elected nine (9) members of the Town Council hereinafter referred to as the Council. There shall be three (3) members of the Council elected from each of the three (3) voting districts. Each political party shall nominate two (2) candidates from each of the three (3) districts. This shall not preclude an individual from running in his district as provided in General Statutes. The three (3) candidates having the largest number of votes from each of the three districts will serve on the Council. All electors in the Town will be eligible to vote for two (2) candidates in each district. [The maximum number of members, as defined by Section 402 of this Charter of the same political party shall serve on any elected Board, Commission, or the Council and] No more than six (6) members of the Council shall be of the same political party, provided further however, that no more than 2 members of the same political party shall serve on the Council from any single district. For the purposes of this section, political party [is defined as the party of endorsement] shall be determined in the same manner as set forth in General Statutes § 9-167a (g), as may be amended.

(e) All elective officers shall hold office until their successors have been chosen and qualified. All elective offices, with the exception of the **Mayor**, Council, Town Clerk, Board of Education, and Registrars of Voters, shall take office on the first Monday following election. The Town Council shall take office as herein provided. The Town Clerk and Registrars of Voters shall take office in accordance with General Statutes. The Board of Education shall take office within seven (7) days following election.

SEC. 302. CHAIRMAN

(a) The Council shall meet at [8:00] **7:00 P.M.** on the second Wednesday following its election to organize and to elect a Chairman and a Vice-Chairman. This will be the first order of business. The Mayor will preside, without vote, over the Council until this order of business is completed. The Chairman of the Council shall have a regular vote only. The Chairman shall preside over all meetings of the Council and perform such other duties consistent with his or her office as may be imposed by the Council. Unless otherwise specified herein, during his or her absence or disability, his or her duties shall be performed by the member of the Council chosen by the Council as Vice-Chairman. The Chairman of the Council is an ex-officio member, without vote, of all Legislative Committees. The Town Council shall make no contracts, verbal or written, from the date of the election, until the successor council has been sworn in.

SEC. 402. MINORITY REPRESENTATION. (a) Minority representation on all boards, commissions, committees, departments, or similar bodies, whether elective or appointive shall be in accordance with the following table:

[(a)] **(b)** Those boards, commissions. committees, departments, or similar bodies, whether elective or appointive with more than nine (9) members shall have no more than 2/3 of their members from the same political party.

[(b)] (c) Vacancies in appointed positions shall be posted on the Town website for a minimum of five days prior to the appointing authority taking action on any final appointments. Any person affiliated with a party or not so affiliated shall have the ability to submit their name to the appointing authority. The appointing authority shall give due consideration to the recommendations of the major political parties before final appointments are made.

(d) General Statutes § 9-167a and all of its parts, as may be amended, shall apply to all boards, commissions, committees, departments, or similar bodies, whether elective or appointive, with respect to minority representation, excepting therefrom, however, the Town Council which shall be governed in accordance with Sec. 202 of this Charter. Notwith-standing the foregoing, in applying the minority representation rule contained in Sec. 202 to the Town Council, political party shall be determined in the same manner as set forth in Connecticut General Statutes § 9-167a (g), as may be amended.

SEC. 404. LIBRARY BOARD OF [DIRECTORS] **TRUSTEES**. The Town Council shall appoint a Library Board of [Directors] **Trustees** to consist of [seven (7)] **nine (9)** electors of the Town, not more than [four (4)] **five (5)** of whom shall belong to any one political party. The Library Board of [Directors] **Trustees** shall appoint the Town Librarian and library employees and carry out all other duties as prescribed by General Statutes and Town Ordinance. Terms of office shall be consistent with this Charter.

SEC. 408. CHIEF OF POLICE

(e) The police chief shall submit to the Town Council a promotion policy and organizational chart for approval within three months of ratification of this charter. No promotions may be made without a current Council approved promotion policy and organizational chart in place. Promotions within the Police Department shall be made according to the approved promotion policy and organizational chart. All promotions recommended by the police chief in accordance with the approved promotion policy and organizational chart shall be submitted to the Mayor [and the Town Council] for final approval. Subsequent revisions to the Police Department promotion policy and organizational chart must be submitted to the Town Council for approval.

[(A) CIVILIAN POLICE REVIEW BOARD

(a) General: There shall be a Civilian Police Review Board (CPRB), which will receive, investigate and make appropriate recommendations to the Mayor and Chief of Police of the Town of Wolcott regarding complaints of citizens not excluding employees of the Police Department, against members of the Wolcott Police Department and/or civilian employees thereof.

(b) Powers and Duties of Board: The CPRB shall be notified by the Mayor's Office, the Chief of Police and or any individual member of CPRB of any and all complaints against members of the Wolcott Police Department and/or civilian employees thereof whether such complaints be written, oral or anonymous.

The CPRB shall be provided with all police documents, reports, electronic transmission, videotape and any other transcriptions related to any civilian complaint. (The Chief of Police may take appropriate actions to maintain the security of police documents, reports, electronic transmissions and videotape reviewed by CPRB) The CPRB may request the Chief of Police conduct appropriate internal affairs investigations of serious complaints against members or civilian employees of the police department. The CPRB shall review the conclusions of any internal affairs investigation of a complaint prior to any disciplinary action being taken and recommend further investigation to the Chief of Police if appropriate. The CPRB may request written statements made under oath through the Chief of Police from any member or civilian employee of the department and of the complainant in order to fully investigate any complaint. The CPRB shall make a written report of their investigation and findings and their

recommendation as to discipline to be taken if any regarding all complaints, when appropriate, to the Mayor and Chief of Police, however, the CPRB shall not have authority to impose discipline. The Chief of Police and/or Mayor, where appropriate, shall make the decision regarding discipline. The Chief of Police and/or Mayor shall explain his or her disciplinary action in writing for each complaint if different from the recommendation of the CPRB.

- (c) The Civilian Police Review Board shall consist of five members, no more than three of whom shall be members of the same political party.
 - (i) Town Council Representative: One Town Council member shall serve as a liaison to the CPRB.
 - (ii) Appointments; term of office. No later than January 1, 2011, the Mayor with Town Council approval shall appoint five (5) members for a term of two (2) years and thereafter, in accordance with Section 401.
 - (iii) No Compensation. Members shall serve without compensation.
- (d) Organization of Civilian Police Review Board: During January 2011 and January of each odd numbered year thereafter, the Board shall select from among its members a chair, vice chair and such other officers as it may desire.
 - (i) Secretary and record keeping. The Mayor shall appoint a secretary to the Board which secretary may not be a member of the Board. The Town Clerk shall act as record keeper for the Board.
 - (ii) Meeting Schedule. The Board shall meet no less than two times per year. The organizational meeting shall be no more than 30 days after the appointment process of each term.
 - (iii) Authority and actions of members. No member shall have any authority to act on behalf of the Board except pursuant to an order regularly made at a meeting of the Board.
 - (iv) Quorum and voting requirements. Three members shall constitute a quorum and a concurrent vote of no fewer than three members shall be necessary for the transaction of business.
 - (v) Public meetings and public participation. All meetings, except executive sessions, as defined in the State Freedom of Information Act or any successor thereto, shall be public. At the start of each regularly scheduled public meeting the Board shall allot a minimum of 15 minutes for public speaking, with a minimum of three minutes per speaker.
 - (vi) Bylaws. The Board shall have the power to adopt its own bylaws for the conduct of its business accordance with the provisions of this code.]

SEC. 410. PLANNING AND ZONING COMMISSION. The Mayor shall appoint a Planning and Zoning Commission subject to the approval of the Council which shall consist of five (5) electors of the Town, not more than three (3) of whom shall belong to any one political party, with duties as prescribed by the General Statutes. The Mayor shall appoint with the approval of the Town Council three (3) alternate members to the Commission, not more than two (2) of whom shall belong to any one political party.

SEC. 423. PERMANENT PENSION COMMITTEE. [The Mayor shall appoint a Permanent Pension Committee] **There shall be a Permanent Pension Committee** consisting of 7 electors of the town whose membership and duties shall be prescribed by Town Ordinance and whose terms of office shall be consistent with this Charter.

SEC. 427. CIVILIAN POLICE REVIEW BOARD

- (a) General: There shall be a Civilian Police Review Board (CPRB), which will receive, investigate and make appropriate recommendations to the Mayor and Chief of Police of the Town of Wolcott regarding complaints of citizens not excluding employees of the Police Department, against members of the Wolcott Police Department and/or civilian employees thereof.
- (b) Powers and Duties of Board: The CPRB shall be notified by the Mayor's Office, the Chief of Police and or any individual member of CPRB of any and all complaints against members of the Wolcott Police Department and/or civilian employees thereof whether such complaints be written, or all or anonymous.
- (c) The CPRB shall be provided with all police documents, reports, electronic transmission, videotape and any other transcriptions related to any civilian complaint. The Chief of Police may take appropriate actions to maintain the security of police documents, reports, electronic transmissions and videotape reviewed by CPRB.  - (ii) Meeting Schedule. The Board shall meet no less than two times per year. The organizational meeting shall be no more than 30 days after the appointment process of each term.

 - (iv) Quorum and voting requirements. Three members shall constitute a quorum and a concurrent vote of no fewer than three members shall be necessary for the transaction of business.

At the start of each regularly scheduled public meeting the Board shall allot a minimum of 15 minutes for public speaking, with a minimum of three minutes per speaker.
 - (vi) Bylaws. The Board shall have the power to adopt its own bylaws for the conduct of its business in accordance with the provisions of this code.

SEC.907. EFFECTIVE DATE. This Revised Charter shall take effect on January 1, [2022] 2025.

Wolcott Historical Society - November 2024

all seems to bring with it an increased interest in cemeteries, so I felt it was time to revisit the history of the five early cemeteries in Wolcott; they are Edgewood, Pike's or Rose Hill, Southeast, Northeast, and Woodtick.

Much history can be acquired by visiting cemeteries. They hold information about its residents, wars, epidemics and disasters that might have affected the town and its people. Early tombstones have many interesting inscriptions and designs carved into them. Symbols found on these stones portray various meanings. For example, the tulip symbolizes immortality and the peacock represents eternity. Historians feel that tombstones carved prior to

1800 were an art form. Early New England stonecutters made stones with various designs and symbols that were time consuming to produce; thus, after 1805 designs and stones became more simplified.

The first burying ground established in the settlement of Farmingbury was Edgewood or Evergreen Cemetery lo-

cated on Bound Line Road near the center of town. In 1764 at a town meeting held in Waterbury, Captains George Nichols and Stephen Upson Jr. were chosen to view and purchase a half-acre of land for a burying ground, which they did. In 1798 at another town meeting, it was agreed to increase the burying ground to three-fourths of an acre. By 1870 this cemetery was again too small, so it was enlarged to almost two acres. Today this cemetery is still in use and has been enlarged several more times and is maintained by a cemetery association. If you visit this cemetery, the original section is on the right as you enter. Some

of the names of the early settlers of our town that are buried there are Alcott, Andrews, Atkins, Beach, Bronson, Finch, Harrison, Kenea, Minor, Pritchard, Norton, Thomas, Tuttle, Upson and many more. Veterans from the French and Indian War, Revolutionary War, the War of 1812, and the Civil War are buried in this cemetery.

The Society of Farmingbury established the Southeast burying ground in 1772. This cemetery is located on property now owned by the town of Southington not far from the intersection of County Road and East Street, but the cemetery is still maintained by the Town of Wolcott. The earliest inscription on a tombstone in this graveyard is January 1, 1782, for Archebald Upson who died at age twenty. There were fifty-two settlers buried in this cemetery from 1782 to 1939. Family names such as Lewis, Upson, Tuttle, Barnes, Brown, Byington, Carter and Frost are found here. Over the years this cemetery has been preserved because of the watchful eyes of the Southington Reservoir crew and two Wolcott residents Gary Gemino and Jay Crocco. Gary and Jay repaired broken stones and

made sure all was well at this beautiful old burying ground.

Pike's Hill or Rose Hill Cemetery was established in 1774 in the northeast section of town off of Woodtick Road. This burying ground was used for about thirty years and contained only a small number of graves. In 1805 the town voted to purchase a larger piece of land down the hill for the new larger Northeast or Beecher Cemetery. Many of

the graves from Pike's Hill Cemetery were removed and placed in the new cemetery. The six stones that remain there are worn down and the names on the stones are almost illegible. Reverend Samuel Orcutt listed these stones in his book, "History of the Town of Wolcott From 1731 to 1874" and stated that three were made of brown stone and three of blue stone. The three brown stones were for Mrs. Rachel Brackitt, who died October 17, 1776; Mr. Mathew Blakslee who died on May 28,1776; and Rhoda Blakslee who died on March 12, 1781. The three blue stone monuments were for Abner Blaksly who died Nov. 27, 1791; Ithamer Alcox, who died Aug. 9, 1778; and Lyman Alcox who died Nov. 17, 1781.

Two Eagle Scout Projects were completed at this cemetery, one by Steve Lago from Troop 231 in 2010 and another in 2019 by Ben Podzunas from Troop 230. Both projects entailed clearing the trees and undergrowth that had taken over the area and standing up several stones. In September of 2024, Tyson Cornelio and his grandmother, Arline Tansley cleaned the leaves and weeds from the area. For more information on these projects go to our website at wolcotthistory.org.

The Northeast Cemetery was created in 1805 on a piece of land on lower Beecher Road off Woodtick Road. This cemetery was established because Pike's Hill became too small. The earliest date on a tombstone in this cemetery was 1781 for Martin Carter, whose grave was probably moved from Pike's Hill to this one. The last burial date found on a tombstone is January 18, 1927, for Benjamin L. Bronson. This cemetery's remote location has allowed it to be vandalized on numerous occasions; vandals have broken or destroyed many of the tombstones. In the fall of 2008, the town crew improved the road leading into the Northeast Cemetery to make way for a major clean up by the Boy Scouts. The Scouts and their leaders spent a full day removing many trees to make room for a new fence that was installed shortly thereafter. Since then, the town crew has kept the grass mowed during the spring and

summer months. In the fall of 2012 Michael Jacobson completed Eagle Scout project there to help stop erosion at the entrance gate. Michael, his team and the town crew worked together to complete this project. They built large steps leading up into the cemetery and planted shrubs and grass seed on each side

of the steps. A stainless sign with a brief history of the cemetery was placed on one of the concrete barriers to let visitors know about its historical significance.

The Woodtick Cemetery is located on Woodtick Road near the corner of Todd Road and backs up to property on Pleasant Street. It was established on November 20, 1807. The entrance to the cemetery is found just south of the Woodtick Memorial and as you enter the dirt driveway you will see the original historic section. This cemetery has been enlarged to allow more gravesites and is under the supervision of a cemetery association. The earliest date of a burial here is Julia Upson on November 21, 1813; she was 20 years of age. Tombstones of many early settlers such as Browne, Byington, Cole, Harrison, Finch, Frisbie, Garthwait, Hall, Hitchcock, Nichols, Todd, Upson, Wakelee, Weber and Welton are found here.

The last cemetery I'd like to mention is Allentown Cemetery. It is in Terryville on Allentown Road just over the Wolcott border. This cemetery has many Wolcott residents buried in it because it located so close to the northwestern border of our town. This cemetery is well-kept and easy to access. To locate this cemetery, follow Spindle Hill Road to Allen-

town Road. The cemetery is located about a quarter of a mile past Todd Hollow Road on the left-hand side of the road. Some early settlers from our town that are buried here are members of the Alcott, Andrews, Lane, Downs, Thomas, Bassett and Allen families.

On November 14th at 2:00 P.M. I will present a PowerPoint discussion at the Wolcott Public Library on old cemeteries of Wolcott. It will include photographs of old tombstones and many old tombstone rubbings that were done in 1991 by some of my Project Explore students from Alcott Middle School.



The Sad Deception of Political Campaigns

s we approach another election, I'm struck by the dishonesty displayed in political advertising. Campaigns today seem to be less about conveying the truth and more about misleading voters, hoping we're too distracted to notice.

In one ad, a Democratic candidate falsely accuses their Republican

opponent of supporting a national abortion ban. Regardless of how you feel about the issue, the point is the blatant willingness to lie. I know the Republican in question, and they have always been pro-choice. Yet, their opponent, desperate for votes, chose to spread misinformation without hesitation.

Republicans aren't innocent either. Some are touting their vote for fiscal "guardrails" back in 2017, conveniently ignoring that those guardrails were attached to one of the most irresponsible spending packages in our state's history. Don't get me wrong — I absolutely support the concept of fiscal guardrails, as they were critical to keeping Connecticut's finances from spiraling further out of control. But let's be honest about the rest of that bill: it also bailed out Hartford for \$550 million and eliminated property tax credits against the income tax for most Connecticut residents.

This dishonesty isn't limited to any one level of government. Candidates across all races — state and national — are manipulating their constituents rather than telling them the truth.

Look at the 2023 Connecticut state budget. Candidates from both parties who voted for it are calling it "the largest income tax cut in state history." Even if that were true, it would be a sad commentary on our fiscal state. The tax cut provides minimal relief targeted at lower brackets — topping out at most \$20-\$25 a month — while the rest of the budget balloons spending by 7.5%, or \$2.7 billion. In reality, this modest tax cut is buried under layers of additional spending and new taxes. Newsflash — you cannot increase spending by billions and then say you are providing tax relief. Talk about rotating the deck chairs...

Here's what they're failing to tell you was in this 878-page bill:

Corporate Tax Surcharge: The budget continues the corporate tax surcharge (§§ 363-365, pg. 201), extending this burden on businesses indefinitely – who will most certainly pass it on to consumers, while misleading taxpayers into thinking relief is on the way.

Healthcare Coverage for Illegal Aliens: The budget extends healthcare under HUSKY to illegal alien children, raising the age limit from 12 to 15 (§§ 298-300, pg. 164). Taxpayers are being forced to pay for healthcare for individuals who are not even legally in the country.

Student Loan Reimbursement Pilot: The budget establishes a new program offering up to \$20,000 in student loan reimbursements (§§ 183 & 184, pg. 113), with no concern for the ballooning cost that taxpayers are once again expected to shoulder.

Baby Bonds Program: The state will pay \$3,200 to each child born under poverty (§§ 151-155, pg. 87). and the funding comes from raiding the already stretched Teachers' Retirement Fund.

DUI Criminal Record Erasure: A new provision allows DUI offenders to erase their records after ten years, sending a dangerous message to law-abiding families and those affected by impaired driving (§ 122, pg. 70).

Debt-Free Community College Costs: The expansion of this program to include returning students is another example of irresponsible spending to curry favor for votes (§ 137, pg. 77).

Union Strike Settlement: The budget sneaks in a \$50 million union strike settlement and the controversial John Lewis Voting Rights Act, inserted without a separate vote, both of which should have been debated independently (§§ 413, pg. 834).

Medical Debt Forgiveness: This is not about helping people—it's about undermining the free market, expanding government control, and empowering politicians to pick winners and losers with your tax dollars. By allocating \$6.5 million to erase medical debt (§ 122, pg. 85), they've decided that taxpayers who paid their bills are now responsible for bailing out those who didn't.

Hartford-Specific Expenditures: The budget throws millions into Hartford-specific projects, such as sewer system repairs and flood damage reimbursement programs, benefiting a select few while statewide taxpayers pick up the tab (§§ 144-149, pg. 85).

XL Center Renovations: Allocating \$80 million taxpayer dollars to a failing venue with no transparency, another misuse of taxpayer money (§§ 410-412, pg. 233).

Gender-Affirming Care: The bill also includes gender-affirming care provisions for HUSKY beneficiaries (§ 325, pg. 177), for inmates (§ 321, pg. 175), and legal protections for providers (§ 322-323, pg. 176) — all taxpayer-funded and never openly debated.

These provisions, buried deep in the budget, are being hidden from voters. The candidates who voted for this bill are counting on you not to read the fine print, as they parade the tax cut as their only achievement.

I'm not against tax cuts—far from it. I firmly believe the government taxes us all far too much. But it's disgraceful when candidates, whether incumbents or challengers, lie to voters about the contents of a law. They're not doing this to help their constituents; they're doing it to get re-elected.

I've been attacked dishonestly many times in my career. Every election cycle, my opponents launch last-minute attacks filled with falsehoods, forcing me to scramble to set the record straight. But here's the thing—I read the bills. I know what I'm voting for, and I can defend it, because I don't lie to the people who trust me to represent them.

Right now, my opponent claims I've done "nothing" for my constituents. I could list a few achievements to refute that, but the most important one is this: I tell the truth.

The lesson is simple: be wary of campaign promises and accusations, no matter the party. Do your own research. Read the bills. Over time, you'll learn who genuinely represents you and who is just fighting to stay in office.


Learning Through Measurement



- Physicals are state-mandated for Pre-k, K, 6th, and 10th grade
- 7th grade state-required meningitis vaccine and Pre-K flu shots
 An updated order for epipens (and the medication) is needed to participate in athletics, safely attend field trips, and dances/prom. New doctor orders are needed each year for medication (including Tylenol and Motrin).

 Forms can be found on www.wolcottps.org -> Departments -> Health Services -> Forms.

- Medication should be in its original container with their name on it. The medication needs to be brought in by the parent (unless self carry orders) and given to the nurse.
- Vision and hearing screenings will be taking place Parents will be notified if a referral is recommended. Parents may exempt their child from screenings for religious reasons and must provide the school with a written request for exemption.
- Students must have a signed sunscreen form on file each year and self carry and apply it.
- If a child requires crutches or a wheelchair a MD note is needed for them and to use the elevator.
